The PTA's Annual Fund Envelope Drive is the primary fundraiser for Clyde Hill Elementary. We *highly encourage* you to donate all or majority of your donation now as this helps the PTA with planning for the school year.

The PTA provides support staff, books and software for classroom and home use, Science and Heritage Fairs, all-school events and activities, Trunk or Treat, Field Trips, 5th grade graduation events and MUCH more.

How the PTA Annual Fund supports every child:

- Start-up Funds for every teacher to set up their classroom.
- Field trips! These cost as much as \$3,000 per grade.
- Educational software for home or school use at a cost of over \$8,000 annually.
- Extra school support staff at a cost of over \$100,000 per year.

Our PTA must raise \$190,000 this school year to continue to provide our current level of support for every student. This is estimated to cost the PTA \$400 *per* student.

The PTA understands that not every family can make a donation at this time, but donations of any amount are greatly appreciated and welcome!

Please return the yellow envelope to school by Friday, November 3. Every returned envelope (*with or without donation*) is entered in to a drawing to win fun prizes like Snapdoodle Toys gift card, Principal for a Day, and more!
